Final Settlement Price Revision for Certain August 2024 ERCOT Futures

The ERCOT Board has approved the **Real-Time Market (RTM) price corrections** for Operating Days (OD) August 9, 10, and 20, 2024 on October 10, 2024.

As such, Nodal Exchange is revising the Final Settlement Prices for the Nodal futures contracts listed in Table 1 below (hereinafter the "Impacted Contracts") pursuant to Nodal Exchange and Nodal Clear Rules.

To make this revision, Nodal will create cashflow transactions to reflect the Variation Margin that must be collected or paid as a result of the price difference between the previous Final Settlement Prices and the revised Final Settlement Prices using the corrected prices approved by ERCOT.

Table 1 below shows the difference between the previous Final Settlement Price and the revised Final Settlement Price for each Impacted Contract. Please find a spreadsheet version of this data <u>here</u>.

The cashflow transactions are scheduled to take place on November 6, 2024. Detailed information will be shared directly with the impacted Clearing Members.
